December 14, 2009

Public Hearing

The Ovid Township Board met at the Township Hall on Monday, December 14, 2009. The following members were present: Sue Miller, Supervisor; Larry Omo, Trustee; Nancy Price, Treasurer; Judy Sabaitis, Clerk; and Ron Sampsel, Trustee. Also in attendance were 3 guests.

At 7:15 P.M. the first Public Hearing on Susie Lane was called to order by Sue Miller.

The Board led the guests in the Pledge of Allegiance.

The purpose of the hearing is to establish a special assessment district for road maintenance on Susie Lane under PA 188, to review the estimated costs, and to hear public comment. Sue Miller reviewed estimated cost of \$1,380, which includes road grading, 44 yards of processed gravel and 4 scraping per year. The special assessment district does not include snow removal or dust control. There are twelve properties in the district with an estimated cost of \$115 per property per year.

The regular meeting was called to order by Sue Miller at 7:30 P.M.

A resolution by Larry Omo seconded by Sue Miller, that a special assessment district is established for road maintenance on Susie Lane.
