SUMMER TAX COLLECTION

Payments are to be mailed to the following address: Nancy A. Price, 312 East Central Road, Coldwater, MI 49036. Please make checks payable to **OID TOWNSHIP**. Receipts will be provided only if a self-addressed stamped envelope is included with the tax payment. Ovid Township does not accept credit/debit cards. Payments **MUST BE RECEIVED** by September 14th or they will be considered **LATE**. No Sunday or Holiday payments.

APPLICATION FOR DEFERMENT OF SUMMER TAXES

If you meet one of the following requirements:

1. Has a total gross household income of \$40,000 or less for the preceding tax year,
AND
*is totally and permanently disable, Paraplegic, hemiplegic, quadriplegic,
OR
*is an eligible serviceperson, eligible veteran, or eligible widow or widower,
OR
*is at least age 62
2. Agricultural real property, if gross receipts of the agricultural or horticultural operations in the previous year, or the average gross receipts of the operations from the previous three years, are not less than the total household income of the owner in the previous year or the combined household income in the previous year of the individual members of a

limited liability company that owns the agricultural real property. A limited liability company may claim the deferment under this section only if the individual members of the limited liability company qualified for the deferment under this section before the individual members found the limited liability company.

If you meet one of the above requirements and want to defer your summer taxes until February 12, 2011, please call 517-238-4435 for an application to be mailed to you. This must be completed and returned by September 15, 2010 to be eligible for the deferment.

APPLICATION FOR AN ABSENTEE VOTER BALLOT

Registered voter may request an **Application for an Absent Voter Ballot** if you meet **ONE** of the following requirements:

- A. You are of 60 years of age or older
- B. You expect to be absent from the community for the entire time the polls are open on election day
- C. You are physically unable to attend the polls without the assistance of another

- D. You cannot attend the polls because of the tenets of your religion

If you meet **ONE** of the above items **and** wish to Vote by Absent Voter Ballot:

- A. Please call 517-238-9308 to request an **Application For Absent Voter Ballot**. Leave your name, address and phone #. The application will be mailed to you.
- B. Complete the **Application For Absent Voter Ballot** and return it to Judy Sabaitis, Clerk, 335 E. Central Road, Coldwater, MI 49036. Once your application is processed, a Voter Ballot is mailed to you.

NOTE: If you currently are on the Absent Voter mailing list, you DO NOT need to request an application.
