### **APPLICATION FOR DEFERMENT OF SUMMER TAXES**

If you meet one of the following requirements:

1. Have a total gross household income that did  
not exceed \$40,000 for the preceding tax  
year, AND
  - \* 62 years of age or older, including the  
unmarried surviving spouse of a person who  
was 62 years of age or older
  - \* Paraplegic, Hemiplegic, or Quadriplegic
  - \* Eligible serviceperson, eligible veteran, or  
eligible widow or widower
  - \* Blind Person
  - \* Totally and Permanently Disabled
2. Agricultural real property, if the gross  
receipts of the agricultural or horticultural  
operations in the previous year, or the

average gross receipts of the operations from the  
previous three years, are not less than the total  
household income of the owner in the previous year  
or the combined household incomes in the previous  
years of the individual members of a limited liability  
company that owns agricultural real property. A  
limited liability company may claim the deferment  
under this section only if the individual members of  
the limited liability company qualified for the  
deferment under this section before the individual  
members formed the limited liability company.

If you meet one of the above requirements and want  
to defer your summer taxes until February 14, 2013,  
please call 1-517-238-4435 for an application to be  
mailed to you.

Intent must be filed before September 15, 2012 to be  
eligible for the deferment.
